On the business day of the ANLS AGM, the Nominating Committee Chair or his/her designate shall conduct an election of Officers. Additional members for each position may be nominated from the floor of the meeting. The nomination must be seconded, and the nominee must accept the nomination. Each voting member shall print the additional nominees on their ballot.

Due to the confusion in the way nominations from the floor was handled at the 2018 AGM – the process this year has been modified. If you have any questions, please inform the ANLS office.

#### NEW PROCESS:

1. NO BALLOTS will be mailed out.
2. NOMINEE LIST will be posted on the ANLS Members Only Site.
3. PROXIES will be posted on the ANLS Members Only Site. Members who cannot attend the AGM in person will be asked to print off a Proxy and give to another member who will vote on his/her behalf.
4. Members will be asked to pick up the certified Ballot along with their Voting Cards at the Registration Desk prior to the Business Meeting on Friday, April 12, 2019. All Proxies must be signed.
5. Once the floor Nominations cease all members will be asked to place the certified Ballot in the Ballot Box, which will be handed to the Scrutineers.
6. Any Ballot not sealed with the ANLS seal will be spoiled.
